Richard Talbot

In my three years on the Board (one year as Vice-President and one year as President) I was instrumental in accomplishing some very good things for Linden. I started a scholarship foundation for Linden with Licensing, IRS filing, and Foundation By-Laws now complete. This Scholarship Foundation will be a huge benefit for all Linden members, High school golfers, and our local communities. I Introduced Gil Hulsmann of Abbey Road for Flood control with government agencies appraisal. Though Gil's efforts, our course will get huge improvements, paid for by local and federal government grants. As President we combined our Ladies Club with the club Board. This has made us one club and improved communication with the Ladies organizations. I introduced new employee contracts (which were non-existent),



improving the written understanding of our employees and club relationship. Combined all club records in one storage location so all club officers have access to records. Started club officer meetings to improve information needed for the functioning of our club. Spent time knowing our landlords (Leaseholders) on a first name basis, and keeping the good rapport with them as was done by Dave Leon for many years. Encouraged the use of our funds to purchase updated and new equipment for our course and pay cash, so we are not carrying loans to pay. With Ed Ortiz, President and me Vice President, negotiated the new easement for our road and sign with the owners and Dave Qunell. Worked with our neighbors the Elks to improve relations with them. Encouraged all members to participate on any committee; this produced some of the best tournaments and membership drives we have had. Received bids and negotiated for the asphalting of the cart barn area and gravel for cart paths.

Problems facing Linden, in the future, and why I am willing to run for the Board again. At this point in time without good coordination from the Board to the Scholarship foundation we could have problems

getting it started. I would be active on the Board to promote this foundation's success. Gil Hullsman has informed me that several Board members have sought to have him replaced. I am not sure why, but I would negotiate to prevent this from happening and possible legal ramifications for breach of contract, as Gil's business is a leader in the communities for engineering and development. The Ladies committee needs strong support on the Board and I would continue to provide this support to our lady members. There may be few or not any Board members left on our Board that is aware of past employee negotiations. Our employees are of course very important to keeping our club running. Again few or none of current Board members have met or know our leaseholders. I would continue to keep in touch with them as our lease has still not been renegotiated for extension. I have worked on this Lease renegotiation in the past and would continue to do so if on the Board. I would watch and care for your money in a responsible way, keeping us out of debt and working with all Board members to achieve this goal. As you can see the easement road is not complete and our sign has not been installed. This last year I was a Board member only and negotiations with Dave Qunell had trouble with our sign. If on the Board I would be the only Board member that has been working with him from the start and would fight to make sure he upholds his signed agreement with us. Membership this last year has dropped to an all time low. If I was on the Board and had the opportunity to be elected President again, and even if not, this would change. Our membership would increase by marketing plans I could put in place.

There are rumors and innuendo floating around regarding my demeanor during my presidency. Rest assured, unless you were privy to all of the discussions at the board meetings, all of these rumors proved to be false or elaborated.

My year as President, I was elected by 51 percent of the voting Board members.
